

Parent and Family Engagement Policy

In support of strengthening student academic achievement, John F. Section A: JOINTLY DEVELOPED

John F.  - Parents will learn how to monitor their child's progress through parent workshops, and also receive information about working with educators. A powerpoint presentation with this information is available for parents to take home.
 - Teachers will give parents information about school curriculum during report card conferences and at back to school night.

Section H: BUILDING CAPACITY OF SCHOOL STAFF

John F. McCloskey School will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

In the Fall, the Principal will conduct a professional development session for staff on how to work effectively with parents as equal partners. Parent survey data feedback will be discussed to ensure staff understand the needs of parents and how to best involve parents in their child's education.
